TERMS AND CONDITIONS

All charges published are for UK customs clearance and ground handling services for PrimeFlight Cargo Ltd and handled carriers where applicable.

General

- Cash is not accepted. Payments can only be made by credit card, debit card or BACS transfer. Payments can only be made by credit card or debit card, with chip and pin being used upon collection of cargo from our facility. Please note we do not accept American Express.
- We are unable to accept card payments taken over the phone. Those wishing to make a BACS payment can only use this facility between 09:00 – 16:30, Monday to Friday. An admin charge of £25.00 will be made when BACS process is used.
- Charges are calculated based on chargeable weight of the consignment.
- Charges are minimum rates and may be increased if additional work or expenses are involved.
- The tariff is subject to alteration without notice.
- Status 1 shall be calculated on the original MAWB or HAWB status 1 date and not from the date an amendment was made to the original record or renomination.
- Any shipments of Section 1 or 2 firearms/ammunition not declared as such on MAWB will be treated as Section 5 and escort fee will apply.
- If storage charges incur due to an event outside of PrimeFlight Cargo control, then the full storage charges will be applicable, including seized or shipments under investigation.
- Other services and charges are available upon a request.
- Shipments requested to be withdrawn and removed from our facility after the acceptance will be subject to all applicable THCs including minimums.
- PrimeFlight Cargo will continue charging Crisis Surcharge on import shipments in 2025 (*£0.05 per kg with a minimum charge of £10.00*).
- LHR facility warehouse is open 24hrs a day 365days a year. Operations Office is open 07:00 – 20:00.
- Shipments which are subject to X-ray screening and additional method of security screening will attract charges for both security screening services.

Located close to the southern runway, X2 fronts the A30 and has direct access onto the Southern Perimeter Road. The building is adjacent to one of the airport's principal road junctions which links through to four motorways, with the M25 only 4.1 miles away.

For airside access, Control Post 22 is 1.1 miles away, Control Post 24 is 1.8 miles away and the Cargo Terminal is 2.2 miles away.

X2 is 100 yards from Hatton Cross Underground (Piccadilly Line) and bus station, giving excellent public transport links to London and the surrounding residential areas. Heathrow Cargo Terminal is located on the southern side of Heathrow Airport and is accessed via the Southern Perimeter Road. The M25, M3 (J1) and M4 (J4b, J4a, J4, J3) are a short drive away for national and central London access.
